what is a design consultation?

A Design Consultation is a unique approach to offering design expertise with services charged at an hourly rate appropriate to the level of service requested. It consists of providing ideas and objective information to clients who currently do not need the complete array or delivery of professional design services.

The consultation entails cooperative meetings in which clients present their needs and circumstances and the Architect helps identify and solve problems. The Architect is a source of information in addition to actual design services. The client will leave the meeting with a clear set of facts, some new ideas, and a specific list of the next steps to take.

It allows clients to do their project in segments. Clients may prefer very limited services such as advice on building codes or reliable data on local construction costs and contractors or giving ideas on how to get maximum rent or resale value out of a piece of property.

The client may be satisfied with the results of the consultation service in as little as one or two hours. Design Consultations may eventually lead to full standard design services. However, the Architect's objective will be to deliver valuable information for a client within a single meeting that will aid them in making the next step.

Clients get expert advice from professionals who prove, by word and deed, that they provide the appropriate level of services to meet the immediate needs. They will work to minimize the client's costs and give objective advice.

sample design consultation scenarios

A couple, unsure of the costs and feasibility of adding onto their home, debating whether to add onto their current home or move to a new home

A restaurateur wanting to do her own remodeling planning and construction, but in need of specific guidance and confirmation of ideas

A pair of real estate investors, wanting to brainstorm ideas for new uses for a vacant shopping mall

An attorney considering buying an older building in town for his office. He would like to know the remedial and code issues before he buys the building. He takes along his consultant to a walk through for on the spot advice. Later, he may need additional services for a due diligence report, feasibility studies or design services.

A family with a roof leak by a chimney at the home entrance. After several unsuccessful fixes, they consult with the Architect to seek solutions for removing the chimney and redesign the entrance to their home.

Review of potential real estate purchases to comment on feasibility of converting to intended use.

Schematic plans, material selections, etc., for residential or commercial projects.

Recommendations and referrals: contractors and subcontractors, sources of materials, etc.

what should the client bring?

- Site survey, map, and relevant property legal descriptions, appraisals, soil reports, etc. when available
- Property photographs (as recent as possible)
- A "wish list" of what the client wants most from the project
- A list of the most important questions the client wants to have answered
- Any and all clippings, notes, sketches, etc. pertinent to needs and ideas
- Information on budget considerations
- Information on scope requirements + considerations

what does it cost?

fees

The base fee for a Design Consultation is \$300.00, which includes a session up to 2 hours and covers our travel time (within 25 miles of our office). After that we charge \$150.00 per hour for subsequent consultation time (in 15 minute increments). Most sessions range from 1-1/2 to 2 hours but can extend longer depending on the client and their interest in continuing the discussion, questions and in some cases sketching possible solutions.

Payment is rendered at the conclusion of the session.

reimbursables

Common items such as telephone charges, fax, photocopying, and printing are billed at cost if session is held at the architect's office.
